# Detroit Athletic Club's Vito P. Gioia II Selected BoardRoom's Distinguished Club President for 2023

Vito P. Gioia II, the 106th president of the Detroit Athletic Club, has been fascinated with numbers, a drive to succeed and a way with people since childhood. "Our selection of the top 20 presidents and Vito Gioia, president of the Detroit Athletic Club, as our *Distinguished Club President* signifies another successful search for leaders who have contributed so much to their private clubs and their member experience," expressed John Fornaro, the *BoardRoom magazine*'s publisher, and CEO.

"Congratulations to all our board presidents of the year and Vito Gioia for his efforts to become our *2023 Distinguished Club President*. With over 400 applications, many of them have had success. It's been a challenge this year to get that number down to 21.

"Helping their club define objectives, establish major goals, and stay focused on its direction over time, as well as hiring a CEO/GM, is what we consider when making our decisions," Fornaro added.

"At our board orientation, we emphasize stewardship of three main areas: long-term strategic vision, operational oversight and governance. We encourage our directors and members to be curious, not judgmental – especially when it comes to the oftencounterintuitive nature of the hospitality industry.

"Over time, we have found that the most effective directors have a mentor or 'board buddy' to coach them through the early years and complex matters in front of the board. I believe in turning common sense into common practice, so this year, we thoughtfully assigned mentors to directors in their first and second years to ensure engagement and understanding."

"Also, the board president working hand in hand with CEO/GM, collaborative governance and not micromanaging them is the most critical. I've seen one lousy board president take a club back many years because of their poor leadership.

"In the future, we will be adding the board president's role in education and informing new committee members as part of our criteria. It should be a priority of every CEO/GM and board president to prepare them for future board positions," Fornaro stressed.

"A 2019 survey showed that fewer than three percent of board members had previous experience with 501(c)7 or (c)3 organizations. Ninety percent of private clubs are equity clubs and the vast majority are 501(c)7 or (c)3organizations. There are many differences, such as fiduciary and legal issues, ongoing compliance obligations, and management oversight, to name a few.

"And congratulations to Kopplin Kuebler & Wallace for their continued sponsorship and support over the past 20 years. Immersed in the private club industry, they understand the importance of a qualified, informed and collaborative board president to a club," Fornaro added.

The impetus for *BoardRoom's Top President* recognition program comes from the *Association of Private Club Directors*, the parent organization of Boardroom magazine and Kopplin Kuebler & Wallace, one of the country's leading private club industry consultants and executive search firms.

"President Gioia effectively maintained alignment of club, board, committee, and management team goals through the strategic plan. They all support, in some way, objectives outlined in our strategic plan," expressed Executive Manager Johnson. "This ensures that everyone in governance and management works on corresponding items and strives to achieve the same collective goals.

"Micromanagement has not been an issue at the DAC. Like many clubs, we've been conscious of that in recent years and intentional with our efforts to avoid it. President Gioia does a great job keeping the board's focus strategic and not operational. During board meetings, he is quick to redirect any discussions that stray from our strategic focus," Johnson added.

So, how does the club handle the growth of its board of directors?

"We have annual board retreats that focus on strategy, industry education, and camaraderie. The executive committee works with the executive manager to develop each retreat's agenda, topics and supplemental materials.

"Ongoing education for the board is a point of emphasis for us. It begins with the annual board orientation, which is attended by all board members, not just the new ones. We're also very conscious of including an educational component for each board meeting, tapping into the expertise of our management team and other industry experts," Johnson explained.

### The Detroit Athletic Club A Club With A Storied History

Many organizations have graced the pages of Detroit's history, but few have impacted the community as much as the Detroit Athletic Club.

Like a boulder in the midstream of a river, the DAC has shaped more than 100 years of Detroit history since its establishment in 1887.

The original club, founded by a group of privileged young men under the spell of amateur athletics sweeping the country at the time, was later reborn in 1913 by a group of the city's prominent automotive and industrial leaders.

They reorganized the DAC and commissioned famed architect Albert Kahn to design the magnificent six-story clubhouse that today stands in the center of the city's theatre and sports district.

The original DAC clubhouse, which no longer exists, was located just south of the cultural heart of Detroit along Woodward Avenue. That first facility was designed primarily as an athletic center with a cinder running track, baseball diamonds, bowling alleys and later, a full gymnasium.

Many of the original club members later were instrumental in creating the current version of the Detroit Athletic Club.

As the 19th century rolled into the 20th, the DAC fell on hard times – many of its young members, some of whom went off to fight in the Spanish-American War, began to lose interest in amateur sports and focused instead on business development and the growing automobile industry.

The first club nearly closed, save for the efforts of John Kelsey, who personally funded it for several years.

When the new clubhouse opened in April 1915, it marked the culmination of the careful plans and dreams of more than 100 prominent Detroiters, many of whom were automotive pioneers.

Names like Chalmers, Jewett, Kelsey, Joy, Lodge, Metzger, Hughes, Navin and Scripps will forever be associated with the club's 20th century rebirth and its place as a home to industrial titans.

Traditionally, the new DAC was born on January 4, 1913, when 109 leading citizens of Detroit met at the Pontchartrain Hotel to sign articles of association and organize a framework of committees to start the club on its way to becoming the vaunted iteration it is today. BR strengthened relationships within the organization and fostered more trust and camaraderie.

"President Gioia consistently demonstrates foresight and strategic thinking, driving the DAC towards ambitious goals with a visionary leadership style. His ability to anticipate future challenges and opportunities has been instrumental in positioning us to remain the No. 1 Athletic Club in the country and one of the best private clubs in the world.

"It has been an honor and a privilege to serve under Mr. Gioia's leadership. His invaluable contributions as the board chair of the DAC will have a positive and profound impact for years to come," Sanders commented.

"Mr. Gioia is an exceptional governance leader dedicated to our members and our club's future. He doesn't focus on short-term challenges; he leaves that to our capable management team. Vito has always been and continues to be a thoughtful listener and consensus builder while leading the DAC forward," expressed Lorna Utley, a board member and corporate secretary. And we leave the last words to President Gioia.

"When asked if a one-year term as president is long enough, I offer this: when you collectively commit to a longterm strategic plan, a one-year presidential term gives the board the right amount of urgency to get things done. Plus, I would want as many people as possible to serve as president of this amazing club," Gioia added.

"My term on the board has been the best leadership experience of my career. I've made many great friends who have created stories for the ages. Whenever I'm given a microphone, I reiterate this in hopes that we continue recruiting the best leaders in Detroit to lead our club.

"Individual accolades are humbling and they are only made possible by the efforts of the whole," President Gioia concluded, and the so many reasons why President Vito Gioia is *BoardRoom's Distinguished Club President for 2023.* BR
